# Elevated new and diverse talent by partnering with NAA Education Institute for a virtual career fair

The IREM Foundation partnered with the National Apartment Association (NAA) Education Institute to demonstrate their combined commitment to equity, inclusion, and diversity by hosting our second virtual career fair. This year's career fair focused on entry-level maintenance and leasing roles in five cities within the east and southeast regions of the country.

- 18 companies participated
- 681 job seekers registered
- 159 resumes collected
- 226 interviews conducted
- 199 selected for further screening

# Elaina's Sustainability Fund

In 2022, the IREM Foundation awarded grants to five projects focused on the innovation or adoption of sustainability and occupant wellness initiatives that impact buildings where we live, work, shop, and play. These recipients are doing work around the globe to make their communities, homes, and businesses more sustainable, and foster happy and healthy living.





Project: EcoRise


Location: Austin, TX

**About:** EcoRise will support 10 student-led projects that make schools and communities more sustainable. It will directly benefit at least 7,000 students and community members via school building improvements, cost savings, and environmental benefits.









Project: Demi

Location: Chicago, IL

**About:** Demi is on a mission to make composting the new normal. Demi partners with residential building managers to provide an integrated solution while also reducing waste management costs, enhancing sustainability goals, and attracting new tenants.







Project: Apple Patch Community

Location: Louisville, KY



About: Apple Patch Community serves over 250 people with developmental and intellectual disabilities. A grant will support a weatherization pilot in one of 17 homes they own which houses three residents, creating a more comfortable environment and increasing sustainability through air sealing. Following the results and savings earned from the first home, Apple Patch will replicate the project in the rest of the community.

Location: Trinidad and Tobago

About: STAOTT promotes sustainable tourism and energy efficiency amongst the broader tourism business and is working toward green certification readiness for the tourist accommodation facilities through energy usage assessments and energy efficiency upgrades.







Project: Plant it Forward

Location: Houston, TX

About: Plant It Forward's mission is to empower refugees to develop sustainable farming businesses that produce fresh, healthy food for the local community. The grant will support the purchase of two high efficiency walk-in cold storage units in their warehouse to reduce the overall energy consumption of the facilities, which helps prevent food waste and embedded energy.



Back in 1977, when the Foundation and our mission was established, Joseph (Joe) T. Aveni, CPM°, was IREM president. He envisioned an organization that would support IREM members, future real estate managers, building owners, and investors. To help ensure his vision was realized, in 1999 he donated \$100,000 to establish a fund that would support real estate management research.


